TERMS AND CONDITIONS OF THE TENDER

1. General Information:

I. Sealed financial and technical bids are invited from the intending firms/ renowned publishers/suppliers for supply of various books for the library of Mahatma Gandhi Govt. Engineering College. The sealed cover containing the tender should be super scribed "Tender for Supply of Books for Library of Mahatma Gandhi Govt. Engineering College, addressed to the Director/Principal, Mahatma Gandhi Govt. Engineering College Kotla (Jeori) Camp at JNGEC Sundernagar, Mandi, HP, Pin 175018 by Speed Post or Registered Post only and it should reach within the stipulated date and time. Tender paper received after the stipulated date and time will be straight way rejected.

II. Tender Paper can be obtained from the office MG Govt. Engineering College Kotla (Jeori) Rampur HP during office hour on any working day on payment of non-refundable amount ₹500/- (Five Hundred rupees only) in shape of Cash/DD. Completed tender forms may be deposited in the College till 16/01/2023 up to 1:00 PM.

III. Tender documents can also be downloaded from the official website of College www.mggec.ac.in and the cost of the tender form i.e ₹500/- (Five Hundred rupees only) nonrefundable, has to be submitted in form of Demand draft in favour of Director/Principal, Mahatma Gandhi Govt. Engineering College Kotla (Jeori) camp at JNGEC Sundernagar, Mandi HP payable at Sundernagar.

IV. The Technical bid will be opened at office of the Director/Principal, Mahatma Gandhi Govt. Engineering College Kotla (Jeori) Camp at JNGEC Sundernagar, Mandi, HP, Pin 175018 on 16/01/2023 at 2:30 PM and Financial bid will be opened on same day at 3:30 pm in the presence of the Members of the Tender Committee and tenderers or their authorized representatives, who wish to be present. In case date fixed for opening of bids happens to be holiday, bids will be opened on next working days on scheduled time.

V. All credentials, documents and copies of certificates/ information's called for shall be submitted along with the Tender paper duly self-signed by him/her.

VI. Payment to the supplier shall be made after the supply of books to the College point within 45 days. The undersigned may prescribe any other procedure as per procurement procedure of the Government/College.

2. Tender process:

The Tender should be submitted in **two separate closed envelopes** to be inserted in a big envelope which to be super scribed. **First envelope meant for Technical Bid and second for Financial Bid.** After verification the technical bid, the financial bid will be opened for consideration of the firm which fulfils all the required conditions of the tenderer in the technical bid.

3. Technical Bid:

"Technical bid" and contain the following document:-

- (i) Cost of tender form i.e. D.D. of ₹500/- (Five Hundred rupees only) in favour of Director/Principal, MG Govt. Engineering College Kotla (Jeori) camp at JNGEC Sundernagar, Mandi HP payable at Sundernagar (H.P.)



- (ii) Earnest money deposit i.e. D.D. of ₹10,000/- (Rs. Ten Thousand only) in favour of Director/Principal, MG Govt. Engineering College Kotla (Jeori) H.P payable at Sundernagar.
 - (iii) The tenderer shall attach a list of Institutes /Universities for whom they have provided books (if any) with a certified copy of supply orders from the Institutes /Universities for support of the same for last three years.
 - (iv) Enclose certified copy of document of the registration number of the firm.
 - (v) Enclose document of GST No. of the firm.
 - (vi) Enclose certified copy of PAN and TAN Card/Certificate of the firm.
- (Signatory' authority of tender should sign all enclosures in cover 'A' and each page of terms & conditions including Annexure-A).

Note:

- a) All attested documents must be submitted in Hindi or English Language. If the documents are not in Hindi or English, they should be translated in Hindi or English and must be submitted along with the copy of original document.
- b) **Tender will be liable for outright rejection if:-**
 - i. Any rates are disclosed in technical bid i.e. **cover A**
 - ii. Any discounts/special offers are made in technical bid i.e. **cover A**

4. Financial Bid:

Financial Bid duly filled in as given in **Annexure-B** giving the percentage discount in individual envelope should be sent in separate sealed cover hereinafter called, "**COVER B**". COVER- B should also be addressed to the **Director/Principal, MG Govt. Engineering College Kotla (Jeori) Camp at JNGEC Sundernagar, Mandi, HP, Pin 175018** and should be super-scribed "**FINANCIAL BID**". Signatory authority of Tender should sign each page of Financial Bid.

Financial Bid i.e. Cover B will be opened only for those tenderers who technically qualified/satisfy the standards laid down by the details furnished by the tenderer in Cover A, in compliance of terms & conditions of tender.

Period of validity of bids to award the work: Bids shall remain valid for 180 days from the date of submission of bids.

The points relevant for financial bid are:

- I. **The rates for the books are to be quoted as per the attached format only given at Annexure-B. All the books included in the package will be taken as single unit and flat discount considering all books should be quoted. Comparison among the bidders will be done on the basis of highest flat discount offered by the bidders. No bidders shall quote percentage discount below 10%.**
- II. **The bidder who will offer the highest discount will be asked to submit the rates/M.R.P. of books, which will be evaluated / verified by the committee of the institute. After verification and recommendation of institute's committee, the work/supply order will be issued.**
- III. **The work/supply order will not be issued to the bidder who has failed to supply the requisite information mentioned at S.No. I above.**

- IV. Considering the fact that sometimes a particular book/some books is/are out of print etc., keeping this in view at least 85% of the books included in the package needs to be supplied and undertaking in this regard as per Annexure-C shall be submitted by the bidder/supplier during bid submission stage.

5. **Earnest Money:** - Tender shall be accompanied by an earnest money of ₹10,000/- without which tenders will not be considered. The amount should be deposited in the form of demand draft in favour of Director/Principal, MG Govt. Engineering College Kotla (Jeori) H.P camp at Sundernagar payable at Sundernagar. The earnest money of unsuccessful tenderer shall be refunded soon after finalization of tender.

6. **Forfeiture of Earnest Money:** The earnest money may be forfeited in the following cases:-

- a) When tenderer withdraws or modifies the offer after opening of the tender but before acceptance of the tender.
- b) When tenderer does not execute the offer agreement prescribed within the specified time.
- c) When the tenderer does not deposit the security money after the order is given.
- d) When he/she fails to commence the service as per the order within the time prescribed.

7. Tender form shall be typed or filled in ink. Tender filled in with pencil shall not be considered.

8. In case, if it is noticed at any stage that any item supplied by the approved firm does not conform to the required standard of books, the supplier shall be liable to refund the payment thereof, if received. The supplier will not have any rightful claim to the payment of cost of substandard supplies of books which are not in good condition. It may be noted that supply of substandard goods is an offence and the same will be dealt with in the manner prescribed under relevant laws.

9. Quantity

Director/Principal, MG Govt. Engineering College Kotla (Jeori) camp at JNGEC Sundernagar Mandi HP may increase or decrease the quantity as per the actual requirement. All books must be of latest edition.

10. **Rates:** *Tender may be awarded on maximum discount in percentage.* No separate free goods should be offered. Rates must be valid for a period of one year from the date of award of tender.

- a) Delivery should be made to Mahatma Gandhi Govt. Engineering College Kotla (Jeori) Tehsil Rampur, Distt. Shimla, Himachal Pradesh, 172101. The College will pay no cartage or transportation charges; hence the rates must be quoted accordingly.
- b) Net discount must be offered only against the specified column of the items. The net discount must be inclusive of all charges by way of packing, forwarding, incidental of transit charge including transit insurance and any other levies, duties, charges etc. on the product except GST.



- c) Excise duty or surcharge prevailing on the date of submission of the rate must be included in the net rate and should also be shown separately in the Financial Bid (Annexure-B). Prevailing rates of GST etc. should be mentioned explicitly. Taxes not mentioned will not be paid/reimbursed by this College. In the event of any subsequent variation (increase or decrease) in GST by the government (State of Central) the same will be modified accordingly.
- d) Other statutory increase or decrease shall be agreed upon mutually between College and tenderer and revised rate shall be applicable to order received by the tenderer on or subsequent to the date of such increase in government duty.
- e) No paper should be detached from the tender form.
- f) The tenderer shall **sign with seal on every page** of the tender form including Terms & Conditions in token of his acceptance of all the Terms & Conditions of the tender and return the same along with tender. In case of, non-receipt of terms and conditions duly signed with the tender form, the tender will be rejected.

11. Supply Orders: The supply order will be placed to the approved tenderer (and not Agents/Suppliers/Distributors etc.) through registered post. The firm shall have to supply of books within the period of 20 days to the College from the date of issue of supply order.

12. Subletting or assigning contract to third party is prohibited. In case the tenderer violates this condition, Director/Principal, MG Govt. Engineering College Kotla (Jeori) camp at JNGEC Sundernagar Mandi HP shall be at liberty to place the contract elsewhere on the Tenderer's account and at his risk. The tenderer shall be liable for any loss or damage, which the MG Govt. Engineering College Kotla (Jeori) camp at JNGEC Sundernagar Mandi HP may sustain in consequence or arising out of such replacement of the contract.

13. Penalty for Delay

- a) The time specified for delivery in the supply order shall be deemed to be the essence of the contract and the successful Tenderer shall arrange supplies within the period on receipt of order form the College.
- b) In case of delay in the delivery period the penalty shall be made on the basis of following percentages of value of stores which the tenderer has supply:
 - i. Delay up to one-fourth period of the prescribed delivery - 2.5% of total order value.
 - ii. Delay exceeding one fourth but not exceeding half of the prescribed delivery period - 5% of total order value.
 - iii. Delay exceeding half but not exceeding three-fourth of the prescribed delivery period - 7.5% of total order value.
 - iv. Delay exceeding three-fourth of the prescribed period -10% of total order value.

Fraction of a day in reckoning the period of delay in supplies shall be eliminated if it is less than half a day.

- c) The maximum amount of penalty shall be 10% of total order value.

- d) If the tenderer firm requests for an extension of time in completion of contractual supply on account of occurrence of any circumstances beyond control of human being, he shall apply in writing to the authority, which has placed the supply order, for the same immediately on occurrence of the circumstances.
- e) If the tenderer is unable to complete the supply within the specified or extended period, the Director/Principal shall be entitled to purchase the books or any part thereof from elsewhere without notice to the tenderer on his (i.e., Tenderers) account and risk. The tenderer shall be liable to pay any loss or damage which the College may sustain by reasons of such failure on the part of the tenderer. The tenderer shall not be entitled to any gain on such purchases made against default the recovery of such loss or damage shall be made from any sums accruing to the tenderer under this or any other contract with the government. If recovery is not possible from the bill and the demand, the recovery of such amount or sum due from the tenderer shall be made under the act or any other law for the time being in force.

NOTE: It is clarified that Director/Principal, MG Govt. Engineering College Kotla (Jeori) HP may, if necessary, resort to risk purchase without granting any extension as provided in above Condition.

14. All the Books supplied shall be of the best quality/good condition and conforming to the requirement as laid down. The decision of Director/Principal, MG Govt. Engineering College Kotla (Jeori) HP as to the quality/condition of books shall be final and binding upon the tenderer. In case any of the Books supplied are not found as per requirement or declared sub-standard/spurious, they shall be liable to be rejected and any expenses of loss caused to the firm as a result of rejection of supplies shall be entirely at his account.

15. The tenderer must remove rejected Books from the destination where they lie within 30 days from the date of information of rejection. The officials will take reasonable care of such materials but will not be responsible for any loss or damage that may occur to while it is on their premises.

16. The tenderer shall be responsible for the proper packing and delivery of the material to the consignee.

17. No payment will be made for damage, tiered or shortage of books. The tenderer shall make up the loss and shortage found at the checking of the books by the consignee. No extra cost on such account shall be admissible.

18. **Mode of Payment:** The payment will be made through NEFT/RTGS 100% after the successfully completion of job within one month after the competition of job.

19. All correspondence in this connection should be addressed to the Director/Principal, MG Govt. Engineering College Kotla (Jeori) Camp at JNGEC Sundernagar, Mandi, HP, Pin 175018.

20. The quantity indicated in the tender is mere estimates and is intended to give an idea to the prospective tenderers to enable them to decide whether they will undertake to supply the article to this College on most competitive rates. The figures indicated in the tender do not constitute any commitment of the part of department to purchase any of the articles in the quantity shown therein against each or in any quantity whatsoever. It is further made clear that the College does not bind itself to purchase all or any quantity mentioned in the tender and no objection against the quantity



of the indent of approved item being more or less than the approximate quantity will be entertained and shall not be acceptable as a ground for non-supply on the quantity indented.

21. The Director/Principal, MG Govt. Engineering College Kotla (Jeori) HP will have the right to accept or rejection of all or any of the tender without giving any reason for the same.
22. The Director/Principal, MG Govt. Engineering College Kotla (Jeori) HP can extend the original rate contract of the successful tendered, subject to original Terms and Conditions.
23. The Contract for the supply can be repudiated at any time, if the supplies/services are not made to the satisfaction after giving an opportunity to the Tenderer of being heard and after reasons for repudiation being recorded by him in writing.
24. Extra stipulation or any other condition contrary to the above Tender conditions are not acceptable and may render the tender liable to rejection.
25. Legal proceeding if any arising out of the Tender shall have to be lodged in courts situated in Mandi (H.P.) only.
26. The Director/Principal, MG Govt. Engineering College Kotla (Jeori) Camp at JNGEC Sundernagar, Mandi, HP can relax the terms and conditions in the exigency of the College work.
